## Nairobi Summit ICPD +25 UNFPA's Revised Suggested Government Commitments

## **Overall Concern:**

The most aggressive pro-abortion, pro-CSE, and anti-family governments and organizations in the world are funding, organizing, and proposing the outcome commitments for the Nairobi Summit through UNFPA. The UNFPA proposed commitments clearly reflect this.

## **Highly Problematic Proposed Commitments:**

## UNFPA's Proposed Commitment: "universal access to SRH as part of UHC"

**Concern:** See this short video at <u>https://vimeo.com/328053712</u> revealing how UN agencies define "sexual health," which is a component of SRH, to encompass abortion, CSE, legalized prostitution, same-sex marriage, transgender hormone treatment and surgeries, and more. **UNFPA's Proposed Commitment:** "<u>ensure youth access</u> to information, <u>education and</u> <u>services</u> to be able to make informed choices <u>about their sexuality</u> and <u>reproductive lives</u>"

**Concern:** To understand the many harms of UN-promoted sexuality education, see "War on Children: The Comprehensive Sexuality Education Agenda" at <u>StopCSE.org</u>. One example of SRH "services" that help youth make "informed choices" about their "reproductive lives" are those that occur at abortion clinics. Many abortion clinics call themselves SRH service providers.

**UNFPA's Proposed Commitment:** *"integrating the <u>essential SRH package into national UHC</u> <u>strategies</u>, policies and programmes"* 

**Concern:** The Guttmacher/Lancet commission lists "abortion services" and "comprehensive sexuality education" as components of an essential SRH package. See at <u>https://www.guttmacher.org/guttmacher-lancet-commission/accelerate-progress-executive-summary</u>.

**UNFPA's Proposed Commitment:** *"increasing the percentage of ODA earmarked to ensure universal access to SRHR* to complement domestic financing of <u>SRH</u> programmes" **Concern:** See the short video clip exposing the SRH/SRHR agenda of Rutgers, a Planned Parenthood affiliate organization funded by the government of the Netherlands, that is also on the official planning committee for the Nairobi Summit. **UNFPA's Proposed Commitment:** *"investing in <u>youth</u> education, employment opportunities and health, including family planning <u>and SRH services</u>."* 

Concern: Same concerns as already mentioned regarding SRH.

UNFPA's Proposed Commitment: "investing in digital health innovations"

**Concern:** A digital health innovation recently launched by UNFPA is an SRH/CSE phone app for youth found at Tuneme.org. To see the harmful content pushed by this app, use it to search for orgasm, masturbation, oral sex, anal sex, sexual orientation, pleasure, and more. UNFPA says this digital phone app has reached over four million youth in eight African countries.

**UNFPA's Proposed Commitment:** *"young people's health and well-being cannot be discussed and decided upon without their involvement ( 'nothing about us, without us')"* 

**Concern:** UNFPA and IPPF are grooming youth to promote CSE, abortion and controversial sexual rights at the UN and in policymaking venues everywhere. For example, UNFPA and IPPF hosted a 20-year review of ICPD for youth and produced an outcome document called the Bali Youth Declaration that is supposed to represent what the world's youth want. This ICPD youth declaration calls for the legalization of abortion, prostitution (sex work), same-sex marriage, and CSE and SRH services for youth without parental consent. UNFPA and IPPF plan to advance this controversial SRH agenda even further through youth at the Nairobi Summit.

**UNFPA's Proposed Commitment:** "*the right to sexual and reproductive health care in humanitarian and fragile contexts* ... *including SRHR*"

Concern: Same as above regarding SRH and SRHR.
